

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to nicolesimonek.com, and Nicole Simonek and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Nicole Simonek include nicolesimonek.com and Nicole Simonek. The Nicole Simonek website is a blog site. By using the Nicole Simonek website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered, Nicole Simonek may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through Nicole Simonek's public message boards, this information may be collected and used by others.

- Complete the transaction for which the personal information was collected, fulfill the terms of a written warranty or product recall conducted in accordance with federal law, provide a good or service requested by you, or reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform a contract between you and us;
- Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the

- public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
  - Comply with an existing legal obligation; or
  - Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

### **Children Under Thirteen**

Nicole Simonek does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this website.
